SECTION III: GENERAL

1. LIMITATIONS

2. ACCOUNTING CHANGES

This Agreement is based on the accounting system purported by the organization to be in effect during the period. 3. FIXED RATES

If actual costs for this period are determined, an adjustment will be made to a rate of a future year(s) to reflect the difference between the costs used to establish the fixed rate and actual costs.

4. USE BY OTHER FEDERAL AGENCIES

The rates in this Agreement were approved in accordance with the authority in Title 2 of the Code of Federal Regulations (2 CFR 200), and should be applied to grants, contracts and other agreements covered by 2 CFR 200. The organization may provide copies of the Agreement to other Federal Agencies.
